

# 6-DAY MEMBERSHIP APPLICATION FORM 2025/26

Please DO NOT ATTEND THE CLUB unless all required steps are complete. Those responsible for progressing your application WILL NOT process the application unless all steps are complete.

To maintain the integrity and standards of our membership community, all 6-day Membership applicants must complete the formal application process outlined below.

Your application pathway will depend on your existing relationship with the Club:

- Category 1: You are personally KNOWN to the Club CEO, Membership Officer or a current Club Director.
  - Category 2: You are <u>NOT KNOWN</u> to the Club CEO, Membership Officer, or Club Directors.

### **Membership Application Process Overview**

## CATEGORY 1 APPLICANT: KNOWN TO CLUB CEO, DIRECTOR OR MEMBERSHIP OFFICER

**Step 1**: Complete all required form details, including a verifiable Main Place of Residence within a 25km radius of Yarrawonga Post Office

**Step 2**: Obtain nomination signatures from:
- One Full Member, plus

- Club CEO, Membership Officer, or Director KNOWN to the applicant

**Step 3**: Return completed form to Club Reception (9am–5pm daily) and complete full-payment of the \$1,100 joining fee

### CATEGORY 2 APPLICANT: <u>NOT KNOWN</u> TO CEO, DIRECTOR, OR MEMBERSHIP OFFICER

**Step 1**: Complete all required form details, including a verifiable Main Place of Residence within a 25km radius of Yarrawonga Post Office

**Step 2**: Complete the Statutory Declaration (Page 3) and have it signed by an authorised witness (Justice of the Peace, etc)

Step 3: Obtain nomination signatures from:

 One Full Member, plus

 Club CEO, Membership Officer, or Director (Must have witnessed Statutory Declaration and certified ID documents on-hand)

**Step 4**: Return completed form to Club Reception (9am–5pm daily) and complete full-payment of the \$1,100 joining fee

Applicants name will be posted on the Club Notice Board for 7-days before Board review

Application will be reviewed and approved/denied at the next monthly Board Meeting

All approved applicants will need to complete full payment of the Annual Subscription (\$590) and Clubhouse Credit (\$200), and finally attend a New Member Induction Meeting (held within a week of Board approval) before Golf Course and Competition access is granted

#### **Application Notes**

- 1. All 6-Day membership nominees must reside within a 25km radius of Yarrawonga Post Office and must be your principal place of residence.
- 2. All nominees nominated by a Club Director and seconded by a Full Member of at least 12 months standing.
- 3. The entrance fee must accompany this form.

**6-Day Membership** (Inclusive of Golf affiliation fees)

- 4. The nominee will pay the subscription fee, affiliation fee and any other applicable fees when the membership application has been approved by the Board of Directors at the next monthly Board meeting. 6-day membership is conditional upon attending a new members induction meeting within 12 months of this application. Failure to do so may result in termination of membership.
- 5. 6-Day Membership entitles members to 6 days of golfing privileges, which excludes Saturdays.
- 6. Subscriptions are renewable from the 1st June each year, and must be paid by the last day of June, otherwise re-nomination may be necessary.

#### ONLY CATEGORY 2 APPLICANTS TO COMPLETE PAGES 3 & 4.

All prospective 6-Day Members who are NOT KNOWN to either the Club CEO, Membership Officer or a current Board Member must complete the state relevant Statutory Declaration to satisfy the Board of Directors that their Main Place of Residence lies within the 25km radius of the Yarrawonga Post Office.

By definition, the Australian Government specifies that, a dwelling is generally considered to be your 'Main Place of Residence' if:

- you and your family (if applicable) live in it, and
- your personal belongings are in it, and
- it is the address your mail is delivered to, and
- it is your address on the electoral roll, and
- services such as gas and power are connected

#### Supporting Documents

<b>All</b> Category 2 applicants will need to provide supporting documentation to verify their Main Residential status. The following documents will be required.
Primary Documentation: Provide a Certified Copy of either:
lacktriangle a Drivers Licence (bearing the applicants photograph and main residence address), or
lacktriangle Proof of Identity Card (bearing the applicants photograph and main residence address).
Secondary Documents: The Primary Document must be supported by Certified Copies of two of the following:

☐ Letter of Support from Employer
☐ Motor vehicle registration
☐ Electoral Roll Extract
☐ Current Lease or Tenancy Agreement
☐ Proof of Children enrolment at a local school
☐ Utility Notice (Gas, Water Electricity etc)
☐ Bank Statement (sensitised)
Other evidence of current address from reputable organisation.
Primary and Secondary documents need to be sighted by:
• CEO, Membership Officer, or Club Directors at the time of nomination

• And by the Authorised Witness when completing the Statutory Declaration form on Page 4

Barrister or Solicitor; Medical practitioner (GP or Specialist); Pharmacist; Judge or Magistrate; Police Officer or Sherrif Officer; Justice of the Peace; Minister of religion (with authority to celebrate marriage); Bank, building society or credit union officer with at least five years of service.
