APPLICATION PROCESS FOR 6-DAY MEMBERSHIP:

1. Complete all required sections of the membership application form
2. Provide a verifiable main place of residence within 25 km of the Yarrowonga Post Office
3. Obtain nomination signatures from:
 - One current Full Member
 - The Club CEO, Membership Officer or a Director
4. Provide certified identification documents
5. Return the completed form to Club Reception between 9:00am and 5:00pm daily
6. Pay the \$1,100 joining fee in full when submitting the application

ONCE APPLICATION HAS BEEN SUBMITTED:

- The applicant's name will be displayed on the Club Notice Board for seven days
- The application will then be reviewed at the next monthly Board Meeting
- The Board will approve or decline the application

WHEN APPLICATION IS APPROVED, THE APPLICANT MUST:

- Pay the Annual Subscription of \$675
- Pay the Clubhouse Credit of \$200
- Attend a New Member Induction Meeting, held within one week of Board approval
- Golf course and competition access will only be granted once all payments have been completed and the induction meeting has been attended.

REQUIRED SUPPORTING DOCUMENTS

All applicants need to provide supporting documentation to verify their Main Residential status. The following documents will be required.

Primary Documentation: Provide a Certified Copy of either:

- ☐ a Drivers Licence (bearing the applicants photograph and main residence address), or
- ☐ Proof of Identity Card (bearing the applicants photograph and main residence address).

Secondary Documents: The Primary Document must be supported by Certified Copies of two (2) of the following:

- ☐ Rates Notice
- ☐ Letter of Support from Employer
- ☐ Motor vehicle registration
- ☐ Electoral Roll Extract
- ☐ Current Lease or Tenancy Agreement
- ☐ Proof of Children enrolment at a local school
- ☐ Utility Notice (Gas, Water Electricity etc)
- ☐ Bank Statement (sensitised)
- ☐ Other evidence of current address from reputable organisation.

Primary and Secondary documents need to be sighted by CEO, Membership Officer, or Club Directors at the time of nomination

Application Notes

1. All 6-Day membership nominees must reside within a 25km radius of Yarrawonga Post Office and must be your principal place of residence.
2. All nominees nominated by a Club Director and seconded by a Full Member of at least 12 months standing.
3. The entrance fee must accompany this form.
4. The nominee will pay the subscription fee, affiliation fee and any other applicable fees when the membership application has been approved by the Board of Directors at the next monthly Board meeting. 6-day membership is conditional upon attending a new members induction meeting within 12 months of this application. Failure to do so may result in termination of membership.
5. 6-Day Membership entitles members to 6 days of golfing privileges, which excludes Saturdays.
6. Subscriptions are renewable from the 1st June each year, and must be paid by the last day of June, otherwise re-nomination may be necessary.
