

TERMS & CONDITIONS

Win 1 of 3 \$1,000 Pro Shop Vouchers

The promotion is conducted and administered by the Promoter.

The prizes for this promotion are funded by Lion – Beer, Spirits & Wine Pty Ltd ("Lion"). Lion is not the Promoter and is not responsible for the administration or conduct of the promotion or the determination of winners.

1. Promotion Period

The promotion commences during normal opening hours on Tuesday 1 September 2026 and closes at 7:00pm on Monday 29 March 2027 ("Promotion Period").

Entries received outside the Promotion Period will not be accepted.

2. Eligibility

Entry is open to patrons of Yarrawonga Mulwala Golf Club Resort who:

- are aged 18 years or over; and
- purchase an Eligible Product during the Promotion Period.

Employees, directors and management of the Promoter, and persons directly involved in conducting or determining the winners of the promotion, are not eligible to enter.

The Promoter reserves the right to request proof of age or eligibility.

3. How to Enter

During the Promotion Period, an eligible entrant must:

1. Purchase one Eligible Product from any Clubhouse bar at its normal retail price;
2. Receive an entry form/ticket;
3. Complete the required details, including their name and contact number; and
4. Place the completed entry into the promotional entry barrel located in the Main Lounge.

Each qualifying purchase entitles the entrant to one entry.

Multiple entries are permitted, provided each entry relates to a separate qualifying purchase.

Normal Responsible Service of Alcohol requirements apply at all times. The Promoter reserves the right to refuse service or participation in accordance with its RSA obligations.

5. Prize

There are three (3) prizes to be won.

Each prize consists of:

- One (1) × \$1,000 Yarrawonga Mulwala Golf Club Resort Pro Shop Voucher, redeemable at the Yarra Golf Pro Shop.

Total prize pool: \$3,000 AUD.

Each voucher:

- may only be redeemed at the Yarra Golf Pro Shop;
- is not transferable or redeemable for cash;
- cannot be used to purchase alcohol, tobacco or other prohibited products;
- is subject to any reasonable redemption conditions stated on the voucher; and
- expires 36 months from its date of issue.

6. Prize Draw

7. Winner Notification

If the promotion cannot proceed as planned due to circumstances outside the reasonable control of the Promoter, the Promoter may modify, suspend or cancel the promotion where permitted by law.
